## 1. Health Guarantee

The breeder certifies that the puppy is in good health at the time of sale. The following conditions apply:

- Puppy has been examined by a licensed veterinarian.
- Puppy has received age-appropriate vaccinations and deworming.
- Buyer has 72 hours from time of delivery or pickup to have the puppy examined by their own licensed veterinarian.
- If the puppy is found to have a **life-threatening genetic condition** within 1 year of purchase, a replacement puppy of equal value will be offered (documentation required).

### Exclusions:

- Parasites (common in puppies) unless severe.
  - Ear cropping complications (if procedure is selected).
  - Issues due to buyer neglect, injury, or improper care.

## 2. Ear Cropping (Optional)

Buyer may choose to have the breeder coordinate professional ear cropping.

- **Ear Cropping Fee:** \$ \_\_\_\_\_

  - Contact breeder if the dog must be rehomed; breeder has first right of return.

Breeder agrees to:

- Provide accurate records of vaccinations, deworming, and microchip (if applicable).
- Provide continued support and guidance for the puppy's life.
- Maintain transparent communication regarding puppy health and development.

All deposits and payments are final. Replacement puppies may be offered in accordance with the health guarantee but **no cash refunds** will be issued.
